1. IMISEBENZI YEKHOMISHINI YEMISEBENZI KAHULUMENI

IKhomishini Yemisebenzi Kahulumeni (i-PSC) iyisikhungo somphakathi esizimele nesizicabangela ngokwaso, esakhiwe ngokweSigaba 196 soMthethosisekelo WeRiphabhulikhi YaseNingizimu Afrika, we-1996. I-PSC inikezwe umsebenzi kanye namandla, okuphenya, nokuqapha kanye nokuhlola inhlango kanye nokuphatha imisebenzi kaHulumeni. Leli gunya libandakanya ukuhlolwa kwempumelelo, noma ukungabi bikho kwezinhlelo zikaHulumeni. Okwengezwe kulawa mandla ashiwo ngenhla, i-PSC inesibopho sokukhuthaza izindlela zokuqinisekisa ukusebenza ngempumelelo nakahle Emisebenzini KaHulumeni kanye nokukhuthaza amagugu kanye nemigomo yokuphathwa komphakathi njengoba kubekwe kuMthethosisekelo kuyona yonke imisebenzi kaHulumeni.

Igunya le-PSC

IKhomishini ithola igunya layo esigabeni 195 nese-196 soMthethosisekelo we-1996. Isigaba 195 sibeka okukholelwa kukona kanye nemigomo ebusa ukuphathwa komphakathi okufanele ikhuthazwe iKhomishini. Lokho okukholelwa kukho nemigomo yilokhu:

- Izinga eliphezulu lokuziphatha okuhle ngokomsebenzi.
- Ukusetshenziswa kwemithombo okukahle, okwezomnotho nokuyimpumelelo.
- Ukuphathwa komphakathi okuncike entuthukweni.
- Imisebenzi kufanele inikezwe ngokungabandlululi, ngobuqotho, ngokulingana kanye nokungenzeleli.
- Kufanele kuphendulwe ezidingweni zabantu, futhi umphakathi kufanele ukhuthazwe ukuzibandakanya ekwenziweni kwenqubomgomo.
- Kufanele kuphendulwe ngokuphathwa komphakathi.
- Ukwenzela izinto obala.
- Ukutshalwa kokuphathwa kwabantu okuhle kanye nemisebenzi yokuthuthukisa kwemisebenzi.
- Ukuphathwa komphakathi okumele wonke umuntu onomsebenzi wokuqasha kanye nokuphatha abasebenzi ngokwamakhono, ukucabanga okuzimele, ubuqotho, kanye nokubuyisela esimweni esilungile ukungalingani kwesikhathi esedlule.

Ngokwesigaba 196(4) soMthethosisekelo, 1996, **imisebenzi esemqoka kanye namandla** eKhomishini yilawa:

- Ukukhuthaza amagugu kanye nemigomo yokuphathwa komphakathi eshiwo esigabeni 95 soMthethosisekelo eMisebenzini kaHulumeni yonke.
- Ukuphenya, ukuqapha kanye nokuhlola inhlango, ukuphatha kanye nokusebenza kwabasebenzi beMisebenzi kaHulumeni, ikakhulukazi ukubambelela kokukholelwa kukho nasemigomeni eshiwo esigabeni 195, kanjalo nasezinqubweni zemisebenzi kaHulumeni.

- Ukubika ekutholile kanye nezincomo okungenani kanye ngonyaka kwiSishayamthetho sikaZwelonke noma kwiZishayamthetho zezifundazwe njengoba kwenzeka.
- Ukubika izindaba ezikhathazayo zomsebenzi eziphuthumayo kwiziphathimandla ezifanele eziphethe.
- Ukuphenya izikhalazo zabasebenzi bese wenza iziphakamiso zamakhambi afanele.

7. AMALUNGISELELO AVUMELA UKUBANDAKANYEKA KOMPHEKATHI EKWENZIWENI KWENQUBOMGOMO KANYE NOKWENZIWA KWEMISEBENZI

7.1 INQUBOMGOMO NEQOQOMITHETHO OKWAZISAYO

I-PSC iqapha futhi ihlole izinhlelo zemisebenzi kaHulumeni ngenhloso yokunikezela izeluleko, nalapho kudingeka khona yenze uphenyo lokuthola izindlela zokwenza ngcono umsebenzi emisebenzini kahulumeni. Yize i-PSC ingabandakanyeki ngqo ekwenziweni kwezinqubomgomo, ngegunya layo lokuqapha nokuhlola izinga lokuphatha nokwenziwa kwemisebenzi, inikeza umphakathi izwi eliqondile ekutheni bazifuna zihlelwe kanjani izinqubomgomo, ngokubonisana nomphakathi kanye nezinhlelo zokuhlola ukwenziwa komsebenzi ezibalwe ngezansi -

- ukuhlola ukwaneliseka kwezakhamizi, ukuhlola impumelelo yokwenziwa komsebenzi ngokubona kwezakhamizi ezisebenzisa insiza ethile;
- izinhlangano zezakhamizi ezisebenzisa izindlela ezibandakanyayo ukuthola imibono kubantu ngokuthi zingenziwa kanjani ngcono izinhlelo zikahulumeni;
- ukuhlola ukusebenza kwenhlangano kanye nokuhlela ukunikeza izeluleko ezinhlokwani zeminyango kanye nakubaholi bezepolitiki ukuthi lezi zindawo ezimbili zingenziwa kanjani ngcono; kanye
- nokuhlolwa kwezinhlelo nezindlela ezibandakanya ukuhlola okujulile kokufaneleka kwezinhlelo nezindlela, impumelelo nokusebenza kahle kwezinhlelo nezindlela kanjalo nokulungisa kanye nokwenza izinhlelo nezindlela.

I-PSC yenza ukuhlola okuningi okwahlukene okuphelela emibikweni eyethulwa kwiSishayamthetho SikaZwelonke, ISishayamthetho sezifundazwe, kanye neminyango ngaminye. Le mibiko inikezela ngolwazi ezinhlelweni zokwenza izinqubomgomo kanye nemithetho

Noma nini lapho kudingeka, i-PSC iza nemithetho kanye nemihlahlandlela okungathuthukisa ukwenza ngcono ekubuseni kanye/noma ekwenziweni komsebenzi emisebenzini kahulumeni. Kwesinye isikhathi imithetho ekhona kanye nemihlahlandlela/nezinqubomgomo ziyabukezwa ukuthi zifaneleke ezinguqukwani zemisebenzi/zokuhlela emisebenzini yomphakathi.

8. AMAKHAMBI AKHONA EZENZWENI NOMA EKHULULEKENI UKUTHATHA IZINYATHELO

Zikhona lezi zinkambiso ezilandelayo ukuthi abantu babike noma balungise izezo ezisemthethweni okuthiwa azilungile, azifanele noma azilandeli umthetho noma zeziwe i-PSC/OPSC noma esinye sezisebenzi zayo.

8.1 Izingqubo zokubika noma zokulungisa:

- 8.1.4 Umuntu angafaka isikhalazo kumhloli wemisebenzi maqondana nanoma yikuphi ukuphazanyiswa kweMithetho Eyisisekelo yoMthetho Wezemisebenzi, 1997 (Umthetho No. 75 we-1997 – isigaba 78(1)(a)), noma UMthetho Wokulingana Emsebenzini, 1998 (UMthetho No. 55 we-1998 – isigaba 34(e)).
- 8.1.5 Umuntu angafaka isikhalazo kuMvikeli Womphakathi maqondana nesenzo somsebenzi okusolwa sengathi asikho emthethweni noma esingalungile noma ukweqiwa (UMthethosisekelo kanye noMthetho Womvikeli Womphakathi, 1994 (UMthetho No. 23 we-1994)).
- 8.1.6 Umuntu angafaka isikhalazo neKhomishini Yamalungelo Abantu YaseNingizimu Afrika maqondana nesenzo esisemthethweni noma nokweqiwa okusolwa sengathi kungukwephulwa noma kwesabisa noma yiliphi ilungelo eliyisisekelo (UMthetho WeKhomishini Yamalungelo Abantu, 1994 (UMthetho No. 54 we-1994)).
- 8.1.7 Ukuze avikeleke ekujezisweni ngenxa yokudalula okuqondene nokuziphatha okungekho emthethweni noma okungalungile komqashi noma omunye osebenza
