1. SINGOOBANI

IKomishoni yeNkonzo kaRhulumente (Public Service Commission) (PSC) yasekwa ngokweCandelo le-196 loMgaqo-siseko weRiphabliki yoMzantsi Afrika, 1996. Liziko ekukuphela kwalo elisekwe ngokweCandelo le-10 loMgaqo-siseko. UMgaqo-siseko umisela ukuba inye i-PSC kwiRiphabliki yoMzantsi Afrika, inamalungu ali-14, amahlanu kuwo onyulwe ngokwesincomo seNdlu yoWiso-mThetho. Ilungu elinye lonyulwe kwiphondo ngalinye kwalithoba, emva konyulo olwenziwe yiNkulumbuso yephondo ngesincomo sekomiti yeNdlu yoWiso-mThetho lwePhondo. Amalungu kubhekiselwe kuwo njengabaKomishinala kwaye onyulwa nguMongameli. AbaKomishinala abahlanu abonyulwe ngesincomo seNdlu yoWiso-mThetho bazinze kwi-Ofisi eyiNtloko, ngexa amalungu aseleyo azinze kumaphondo abo. Inkqubo yokuqeshwa kwabaKomishinala ilawulwa ngumThetho weKomishoni weNkonzo kaRhulumente, 1997, obonelela ngolawulo lwe-PSC kunye nemicimbi enxulumene nayo, NgokomThetho, uMkomishinala wonyulwa ixesha leminyaka emihlanu, elivuselelwa ngexesha elongezelelweyo leminyaka emihlanu elinye kuphela. I-PSC yonganyelwe nguSihlalo owoonyulwe nguMongameli kubaKomishinala abonyuliweyo.

I-PSC yiyo ethathela kuyo uxanduva lweNdlu yoWiso-mThetho kwaye kufuneka inike ingxelo kuyo ngonyaka. Kufuneka kwakhona inike ingxelo kwiNdlu yoWiso-mThetho yephondo ngokuphathelene nemisebenzi yayo kwiphindo ngalinye.

I-PSC ixhaswa yi-Ofisi yeKomishoni yeNkonzo kaRhulumente (Office of the Public Service Commission) (OPSC), i-ofisi yayo eyintloko isePitoli kwaye ii-ofisi zemimandla zikwiphondo ngalinye. I-OPSC yonganyelwe nguMlawuli Jikelele, oliGosa eliThatha uXanduva. Amalungu angabasebenzi be-OPSC onyulwa ngokomThetho weNkonzo kaRhulumente ka- 1994.

I-PSC ngumbutho ozimeleyo ongakhethi cala osekwe nguMgaqo-siseko, 1996, ukuphakamisa ugqweso kulawulo kwiNkonzo kaRhulumente ngokuphakamisa imo engqongileyo enobugcisa neenqobo ezisesikweni kunye nokongeza ixabiso kulawulo lukarhulumente oluthathela kulo uxanduva, olunobulungisa, olusebenzayo, olukhuthelweyo, olungenalo urhwaphilizo kwaye olusabelayo kwiimfuno zabantu boMzantsi Afrika.

I-PSC ijolise ekuphakamiseni imithetho-siseko yedemokhrasi ekhuselweyo ngokomgaqo-siseko kunye neenqobo ezisemgangathweni zeNkonzo kaRhulumente ngokuphanda, ukujonga, ukuhlola, ukunxibelelana, kunye nokunika ingxelo ngolawulo lukarhulumente. Ngeenkqubo zophando, iyakuqinisekisa ukuphakanyiswa kokugqwesileyo kulawulo kunye nonikezo lweenkonzo ezinobulunga nezinokugcinakala.

2. YINTONI ESIYENZAYO

I-PSC ifumana igunya layo kumaCandelo ele-195 nele-196 loMgaqo-siseko, 1996. Icandelo le-195 limisela iinqobo ezisemgangathweni nemithetho-siseko elawula urhulumente, ekufuneka iphakanyiswe yi-PSC. Ezi nqobo zisemgangathweni kunye nemithetho-siseko yile:

- a. umgangatho ophezulu weenqobo ezisesikweni zobugcisa
- b. ukusetyenziswa kwezibonelelo okwaneleyo, okunoqoqosho nokusebenzayo
- c. ulawulo lukarhulumente oluphuhlise ngokunoqhelaniso
- d. ulungiselelo lweenkonzo ngendlela engakhethiyo, efanelekileyo nenobulungisa, ngaphandle kokuthathwa kwamacala
- e. ukusabela kwiimfuno zabantu kunye nokukhuthaza uluntu ukuba luthabathe inxaxheba ekwenziweni komgaqo-nkqubo
- f. ulawulo lukarhulumente oluthathela kulo uxanduva
- g. ukwamkela ukungafihli
- h. ukuveza ulawulo lwemicimbi yabasebenzi olufanelekileyo kunye nezenzo zophuhliso lwemisebenzi enokulandelwa.
- i. ulawulo lukarhulumente olungumeli olunezenzo zengqesho nolawulo lwabasebenzi ezisekelwe ekubeni nako, ukungathathi icala, ukufaneleka kunye nemfuno yokulungisa ukungafani kwexa langaphambili

NgokweCandelo le-196(4) loMgaqo-siseko, 1996, imisebenzi kunye namagunya e-PSC yile:

- a. ukuphakamisa iinqobo ezisemgangathweni kunye nemithetho-siseko, njengoko kumiselwe kwiCandelo le-195, kwiNkonzo kaRhulumente yonke

- f. mhlawumbi ngokwesivumelwano sayo, okanye ekufumaneni nasiphi na isikhalazo,
 - i. ukuphanda kunye nokuhlola abasebenzi kunye nezenzo zolawulo lukarhulumente kunye nokunika ingxelo kugunyaziwe olawulayo obandakanyekayo nakwindlu yowiso-mthetho
