RULES FOR THE SUMMONSING OF WITNESSES IN CONNECTION WITH INQUIRIES OF THE PUBLIC SERVICE COMMISSION

It is hereby notified for general information that the Public Service Commission, under section 11 of the Public Service Commission Act, 1997 (Act No. 46 of 1997), has made the rules set out in the Schedule hereto.

SCHEDULE

RULES FOR THE SUMMONSING OF WITNESSES IN CONNECTION WITH INQUIRIES OF THE PUBLIC SERVICE COMMISSION

Definitions

1. In these rules, except where otherwise indicated by the context—
 - “**designated official**” means an official of the Office designated under rule 4(1) to serve summonses of the Commission;
 - “**summons**” means a summons which the Commission is competent to issue under subsection (2) of section 10 of the Act with a view to compelling a person—
 - (a) who may be able to give information of material importance concerning the

subject of an enquiry conducted by the Commission under that section, to be in attendance at that enquiry in order to disclose that information to, and be questioned about it by, the Commission; or

- (b) who has in his or her possession or custody or under his or her control any book, document or object which may have a bearing on the subject of such an inquiry, to be in attendance at that inquiry and there to produce such book, document or object to the Commission and, if considered necessary, to be questioned by the Commission about it;

“**the Act**” means the Public Service Commission Act, 1997 (Act No. 46 of 1997);

“**the Commission**” means the Public Service Commission established by section 196(1) of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996); and

“**the Office**” means the Office of the Public Service Commission specified in Column 1 of Schedule 1 to the Public Service Act, 1994 (promulgated by Proclamation No. 103 of 1994).

Form and contents of summons

2. (1) Every summons must substantially be in the form set out in the Annexure to these rules.
- (2) A summons will have been properly issued under section 10(2) of the Act if signed by the Chairperson of the Commission or its designee, and duly completed so as to—
- (a) clearly state the subject of the Commission’s inquiry in connection with which the summons is issued;
- (b) state the following in full:
- (i) the first name/names and surname of the person on whom the summons is to be served (hereafter called the prospective witness); and
- (ii) the residential address or work or business address of the prospective witness;
- (c) specify the day on which and time and place at which the prospective witness is required to appear before the Commission in obedience to the summons;

- (d) clearly indicate whether the prospective witness' appearance before the Commission is required for the purpose of—
 - (i) giving oral evidence and being questioned about matters relevant to that inquiry; or
 - (ii) producing any particular book, document or object in the possession or custody or under the control of the prospective witness,
and must, in the case of subparagraph (ii), clearly and sufficiently specify and identify the particular book, document or object to be produced; and
 - (e) indicate the place where and date on which the summons was signed by the Chairperson of the Commission or its designee in terms of section 10(3)(b) of the Act.
- (3) Every summons must be issued in duplicate.

Commission's summons has force throughout Republic

3. A summons properly issued by the Commission under section 10(2) of the Act, will have force and be enforceable throughout the Republic.

Summons to be served by designated official of the Office

4. (1) A summons must be served, in the manner provided for in rule 5, by an official of the Office designated in writing for that purpose by the Chairperson of the Commission.
- (2) The Commission's Chairperson or any official of the Office acting under the authority of that Chairperson, must issue to each official designated under subrule (1), a certificate signed by the Chairperson or the official of the Office so acting, in which is stated that the person on whose name the certificate has been issued, is authorised to serve any summons of the Commission, and the certificate so issued, is sufficient proof that the person on whose name it has been issued, is so authorised.

Manner in which summons to be served

5. (1) Subject to subrule (2), the designated official must serve the duplicate original of

the summons—

- (a) on the prospective witness personally; or
 - (b) at the prospective witness' residence or physical place of work or business, by handing over the summons, at that residence or work or business place, to some person who apparently is not younger than 16 years of age and who apparently is resident or employed thereat (as the case may be).
- (2) If the prospective witness keeps his or her residence, or, where applicable, his or her place of business, closed so as to prevent the service of the summons, the designated official may affix the duplicate original of the summons to the outer or principal door of that residence or place, which then will constitute sufficient service. However, this mode of service may be used only if the designated official has made at least three unsuccessful attempts, at reasonable times, to serve the summons in the manner provided for in subrule (1).
- (3) Whenever a person on whom a summons is served in terms of subrule (1)(a) or (b), requires proof of the designated official's authority to serve the summons, the designated official must display the certificate of authorisation issued to him or her under rule 4(2).
- (4) After having served the summons, the designated official must make a return of service by endorsing under his or her name and signature, on the original of the summons in the portion specifically designed therefor, the following, namely—
- (a) (i) the first name/names and surname of the person on whom the summons was served, and, if that person is not the prospective witness, the age or apparent age of that person; or
 - (ii) where the summons was served in terms of subrule (2), particulars as to the specific manner in which the summons was so served in the particular case; and
- (b) the date and time when and place where the summons was served.
- (5) The original of the summons must be returned to the Chairperson of the Commission or the Commission's designee for filing and safekeeping in the Commission's records.

Hiermee word vir algemene kennisname bekend gemaak dat die Staatsdienskommissie kragtens artikel 11 van die Wet op die Staatsdienskommissie, 1997 (Wet No. 46 van 1997), die reëls uitgevaardig het soos in die Bylae hierby uiteengesit.

VAN DIE STAATSDIENSKOMMISSIE****Woordomskrywing**

1. In hierdie reëls, tensy uit die samehang anders blyk, beteken—
 - “**aangewese beampte**” 'n beampte van die Kantoor wat kragtens reël 4(1) aangewys is om dagvaardings van die Kommissie te beteken;
 - “**dagvaarding**” 'n dagvaarding wat die Kommissie bevoeg is om om kragtens subartikel (2) van artikel 10 van die Wet uit te reik met die doel om iemand—
 - (a) wat in staat mag wees om inligting van wesenlike belang te verstrek oor die

onderwerp van 'n ondersoek deur die Kommissie kragtens daardie artikel ingestel, te verplig om by daardie ondersoek teenwoordig te wees ten einde daardie inligting aan die Kommissie te openbaar en deur die Kommissie daarvoor ondervra te word; of

- (b) wat in sy of haar besit of bewaring of onder sy of haar beheer enige boek, stuk of voorwerp het wat op die onderwerp van so 'n ondersoek betrekking kan hê, te verplig om by dié ondersoek teenwoordig te wees en om sodanige boek, stuk of voorwerp aldaar aan die Kommissie oor te lê en, indien dit nodig geag word, om deur die Kommissie daarvoor ondervra te word;

“**die Kantoor**” die Kantoor van die Staatsdienskommissie vermeld in Kolom 1 van Bylae 1 by die Staatsdienswet, 1994 (gepromulgeer by Proklamasie No. 103 van 1994);

“**die Kommissie**” die Staatsdienskommissie ingestel by artikel 196(1) van die Grondwet van die Republiek van Suid-Afrika, 1996 (Wet No. 108 van 1996); en

“**die Wet**” die Wet op die Staatsdienskommissie, 1997 (Wet No. 46 van 1997).

Vorm en inhoud van dagvaarding

2. (1) Elke dagvaarding moet wesenlik in die vorm wees soos in die Aanhangsel by hierdie reëls uiteengesit.
- (2) 'n Dagvaarding is behoorlik kragtens artikel 10(2) van die Wet uitgereik indien dit deur die Voorsitter van die Kommissie of dié se benoemde onderteken en behoorlik voltooi is sodat dit—
- (a) die onderwerp van die Kommissie se ondersoek in verband waarmee die dagvaarding uitgereik is, duidelik stel;
- (b) die volgende volledig vermeld:
- (i) die voornaam/-name en van van die persoon aan wie die dagvaarding beteken staan te word (hierna die beoogde getuie genoem); en
- (ii) die woonadres of werks- of besigheidsadres van die beoogde getuie;
- (c) vermeld die dag en tyd waarop en plek waar die beoogde getuie ter voldoening aan die dagvaarding voor die Kommissie moet verskyn;

- (d) duidelik aandui of die beoogde getuie se verskyning voor die Kommissie vereis word ten einde—
 - (i) mondelinge getuienis af te lê en ondervra te word oor aangeleenthede wat by dié ondersoek tersaaklik is; of
 - (ii) enige bepaalde boek, stuk of voorwerp in die besit of bewaring van die beoogde getuie of onder dié se beheer, oor te lê, en, in die geval van subparagraaf (ii), moet die bepaalde boek, stuk of voorwerp wat oorgelê word, duidelik en genoegsaam gespesifiseer en omskryf word; en
 - (e) aandui die plek waar en datum waarop die dagvaarding deur die Voorsitter van die Kommissie of dié se benoemde kragtens artikel 10(3)(b) van die Wet onderteken is.
- (3) Elke dagvaarding word in duplikaat uitgereik.

Kommissie se dagvaarding is van krag regoor Republiek

3. 'n Dagvaarding behoorlik deur die Kommissie uitgereik, is van krag en afdwingbaar regoor die Republiek.

Dagvaarding beteken te word deur aangewese beampte van die Kantoor

4. (1) 'n Dagvaarding word beteken, op die wyse in reël 5 bepaal, deur 'n beampte van die Kantoor wat deur die Voorsitter van die Kommissie skriftelik vir dié doel aangewys word.
- (2) Die Kommissie se Voorsitter of enige beampte van die Kantoor wat op gesag van dié Voorsitter optree, moet aan elke beampte kragtens subreël (1) aangewys, 'n sertifikaat uitreik wat deur die Voorsitter of die beampte van die Kantoor wat aldus optree, onderteken is, en waarin verklaar word dat die persoon op wie se naam die sertifikaat uitgereik is, gemagtig is om enige dagvaarding van die Kommissie te beteken, en die sertifikaat aldus uitgereik, is voldoende bewys dat die persoon op wie se naam dit uitgereik is, aldus gemagtig is.

Wyse waarop dagvaarding beteken word

5. (1) Behoudens subreël (2), moet die aangewese beampte die duplikaat-oorspronklike van die dagvaarding beteken—
- (a) aan die beoogde getuie persoonlik; of
 - (b) by die beoogde getuie se woning of fisiese werks- of besigheidsplek, deur die dagvaarding by dié woning of werks- of besigheidsplek te oorhandig aan iemand wat oënskynlik nie jonger as 16 jaar is nie en wat oënskynlik aldaar woonagtig of werksaam is (na gelang van die geval).
- (2) Indien die beoogde getuie sy of haar woning, of, waar van toepassing, sy of haar besigheidsplek, gesluit hou om daardeur die betekening van die dagvaarding te verhoed, kan die aangewese beampte die duplikaat-oorspronklike van die dagvaarding aan die buite- of hoofdeur van dié woning of besigheidsplek vasheg, wat dan voldoende betekening daarstel. Daar mag egter van hierdie wyse van betekening slegs gebruik gemaak word indien die aangewese beampte minstens drie ondeugdelike pogings, op redelike tye, aangewend het om die dagvaarding te beteken op die wyse waarvoor in subreël (1) voorsiening gemaak word.
- (3) Wanneer ook al iemand aan wie 'n dagvaarding ingevolge subreël (1)(a) of (b) beteken word, van die aangewese beampte bewys verg van dié se magtiging om die dagvaarding te beteken, moet die aangewese beampte die magtigingsertifikaat wat kragtens reël 4(2) aan hom of haar uitgereik is, vertoon.
- (4) Na betekening van die dagvaarding moet die aangewese beampte 'n relaas van betekening voltooi deur onder sy of haar naam en handtekening die volgende te endosseer op die oorspronklike van die dagvaarding, en wel op die gedeelte wat spesifiek daarvoor bestem is, naamlik—
- (a) (i) die voornaam/-name en van van die persoon aan wie die dagvaarding beteken is, en, indien daardie persoon nie die beoogde getuie is nie, die ouderdom of oënskynlike ouderdom van daardie persoon; of
 - (ii) waar die dagvaarding ingevolge subreël (2) beteken is, besonderhede van die spesifieke wyse waarop die dagvaarding aldus in die bepaalde geval beteken is; en

- (b) die datum en tyd waarop en plek waar die dagvaarding beteken is.
- (5) Die oorspronklike van die dagvaarding moet aan die Voorsitter van die Kommissie of die Kommissie se benoemde terugbesorg word vir liassing en veilige bewaring in dié se rekords.
